

CALL FOR CONTEMPORARY PAINTING

FUTURE EXHIBITION AT JOHN WAYNE AIRPORT -Orange County

John Wayne Airport (JWA) is calling for artist submittals of contemporary, non-representational painting, unframed, on 48” x 48” museum depth stretcher bars only.

There is no application fee and if selected, no fee for participation. The exhibition will be 29 paintings by 29 different artists, curated from the submittals to this call for art. Application deadline is January 31, 2022. Artists will be e-notified by February 28, 2022. Selected artists will each receive, a post-exhibition \$50.00 honorarium for participation.

The selected paintings will be exhibited in the locked, tempered glass secured Vi Smith Concourse Gallery art display cases adjacent to the arrival/departure gates in Terminal A and Terminal C. The exhibition run is early May 2022 through February 2023. While JWA does not sell exhibited artwork, any sales resulting from the exhibition are 100% to the artist. All art will remain on exhibit for the run of the exhibition. All inquiries are forwarded to the artist. The exhibition will be one painting per art display case. There are 29 art display cases in the Vi Smith Concourse Gallery.

After post-deadline review of all qualifying applications, only one painting will be curated into the exhibition from each of the 29 artists selected to participate. To qualify for consideration, artists need to provide the completed entry form with the five images and reside in any of the following California counties: Imperial, Kern, Los Angeles, Orange, Riverside, Santa Barbara, San Bernardino, San Diego, or Ventura.

PLEASE NOTE: Artists will be responsible for delivery and pick-up of their selected paintings at the JWA art-handling contractor’s facility located in Anaheim, CA. Address provided with selection notification. Due to lack of any shipping crate storage, hand delivery only, no shipped artwork accepted. Applications will be accepted from individual artists only; no galleries’ or artist representatives’ applications will be considered. The 29 artists will be selected by review of each applicant’s five candidate paintings. Five paintings are required of each applicant to demonstrate aesthetic quality, achievement and creativity. See application form for painting content parameters.

Qualifying applications need to include all of the following for consideration:

- a. Completed artist information entry form and all of the following
- b. Imagery information list matching submitted JPG file titles seen below in Item-h.
- c. Exhibition record
- d. Brief, maximum two paragraph, artist’s statement about submitted artwork
- e. Resume including educational background
- f. Awards, if any
- g. Collections, reviews & P.R. if any
- h. Provide five separate, different JPG’s of five different paintings, no detail views, labeled as follows:

 - 2_ **TITLE** _ **Artist’s Name, Medium, Year of Creation**

A separate email for each image as described in Item h. above, is recommended. Imagery files need to be attachments and ***not*** imbedded in the body of an email.

Artist applications need to be received via email (JWAArts@ocair.com) no later than 4:00 p.m., Monday, January 31, 2022.
